PUBLIC SAFETY COMMITTEE MINUTES

DATE OF MEETING: March 16, 2023 at 5:31 p.m. County Building

MEMBERS PRESENT: Claro Carter – Vice Chair, Tom Farris, John Werts and Melonie Tilley. Also present, Dee Dee Rentmeister, County Administrator.

MEMBERS ABSENT: Megan Myers

SUMMARY OF DISCSSION:

- No one to address the committee.
- Motion by Tilley, 2nd by Farris to approve last month's minutes. Voice vote, motion carried.
- Motion by Werts, 2hd by Tilley to approve the claims. Voice vote, motion carried.
- Micah Gallardo, EMA Coordinator, was present to go over the Intergovernmental Agreement with the City of Clinton to provide EMA services. This is an annual agreement with the City of Clinton paying the county \$15,000 annually. Motion by Tilley, 2nd by Werts to recommend to the full board to approve the Intergovernmental Agreement with the City of Clinton to provide EMA services with the City paying \$15,000.00. Voice vote, motion carried.
- Sheriff Walker presented a quote for 15 tasers. He explained that the current tasers will be given to the correctional staff. These new tasers come with rechargeable batteries and when charging the data is automatically downloaded. The five year agreement would provide the cartridges needed for training as well as cartridges deployed by a deputy. Cost for a five year agreement is \$61,974.25. This expenditure is not budgeted for. Discussion on where the funds could come from i.e., contingencies or ARPA funds. Motion by Tilley, 2nd by Werts to recommend to the full board to approve the five-year agreement with Axon Enterprises for 15 new tasers, rechargeable batteries and cartridges in the amount of \$61,974.25 with the funds coming from contingencies. Roll call vote taken with all members voting yes. Motion carried.
- Sheriff Walker updated the committee on the following:
 - o A newly hired/trained deputy has indicated that he is looking to leave from Bloomington or Normal PD and received a resignation from a correctional officer.
 - o The body camera and in car camera project is complete.
 - o ETSB has agreed to pay \$200,000 for the CenCom 2 channel.
 - o EMA is working with the City of Clinton PD to find funds to purchase digital radios.
- The office/kennel assistant position at the animal shelter has been recreated by the Finance committee and applications are being accepted.
- Motion by Tilley, 2nd by Carter to adjourn at 6:01 p.m. Voice vote, motion carried.

AGREEMENT

This Agreement entered into on the <u>1st</u> of <u>May</u> <u>2023</u>, by and between the COUNTY OF DeWITT, State of Illinois, a body politic, and the CITY OF CLINTON, ILLINOIS, a municipal corporation.

WITNESSETH:

WHEREAS, the governing bodies of the County of DeWitt and City of Clinton, are desirous of entering into a cooperative agreement for the Emergency Management Agency (EMA) of DeWitt County, Illinois; and

WHEREAS, the participating units of government are "units of local government" as defined in Article VII, Section I of the 1970 Constitution of the State of Illinois; and

WHEREAS, the 1970 Constitution of the State of Illinois and 5 ILCS 220/1-3 1992 provide authority for intergovernmental cooperation.

NOW, THEREFORE, in consideration of the mutual agreements contained in this agreement, the participating units of local government agree as follows:

- 1. That the City of Clinton, Illinois, hereby agrees to reimburse the County of DeWitt the sum not exceeding \$15,000.00 commencing May 1, 2023 and terminating April 30, 2024. Said payments shall be paid in four quarterly installments of \$3,750.00 commencing the 30th day of July, October, January and April upon receipt of invoice.
- 2. Payments shall be applied to the ordinary operating expenses incurred for the office and field operations of EMA.
- 3. That should any medical insurance benefits be provided on behalf of said full-time employees, then the County of DeWitt will be responsible for payment thereof.
 - 4. That the full-time employees shall be considered employees of the County of DeWitt, State of Illinois.

Public Safety Committee / DeWitt County Board

In 2017 former Sheriff Jered Shofner entered into a five year agreement with Axon Enterprises to purchase taser package which replaced aging Tasers and provided the cartridges and batteries we need for the life of the agreement. This agreement expired at the end of 2022.

I am requesting that the committee and board would approve funds for my office to enter into a similar five year agreement with Axon Enterprises. With the new agreement we would purchase 15 new T7 Tasers for our patrol deputies. The Tasers that are currently in use by the deputies can be recycled for use in the jail. The agreement also provides the cartridges that we need for training over the next five years as well as replaces any cartridges that are deployed by a deputy, the batteries are now rechargeable and the information from the Taser use is automatically downloaded when charged.

The cost for this agreement is \$61,974.25 which by entering into a five year agreement is a savings of \$9,558.00. This is an expenditure that was not considered when compiling the FY 23 budget, Therefore I am asking if the board could find funds to purchase this agreement.
